**BYLAW No. 870**

A By-law of the Regional District of North Okanagan to establish the Extended Service of Animal Control

**WHEREAS** the provisions of Section 789(a) of the Municipal Act empowers to establish and operate Animal Control as an Extended Service;

**AND WHEREAS** the Regional Board has obtained the assent required under the provisions of Section 797 of the Municipal Act and the consent required under Section 799 of the said Act;

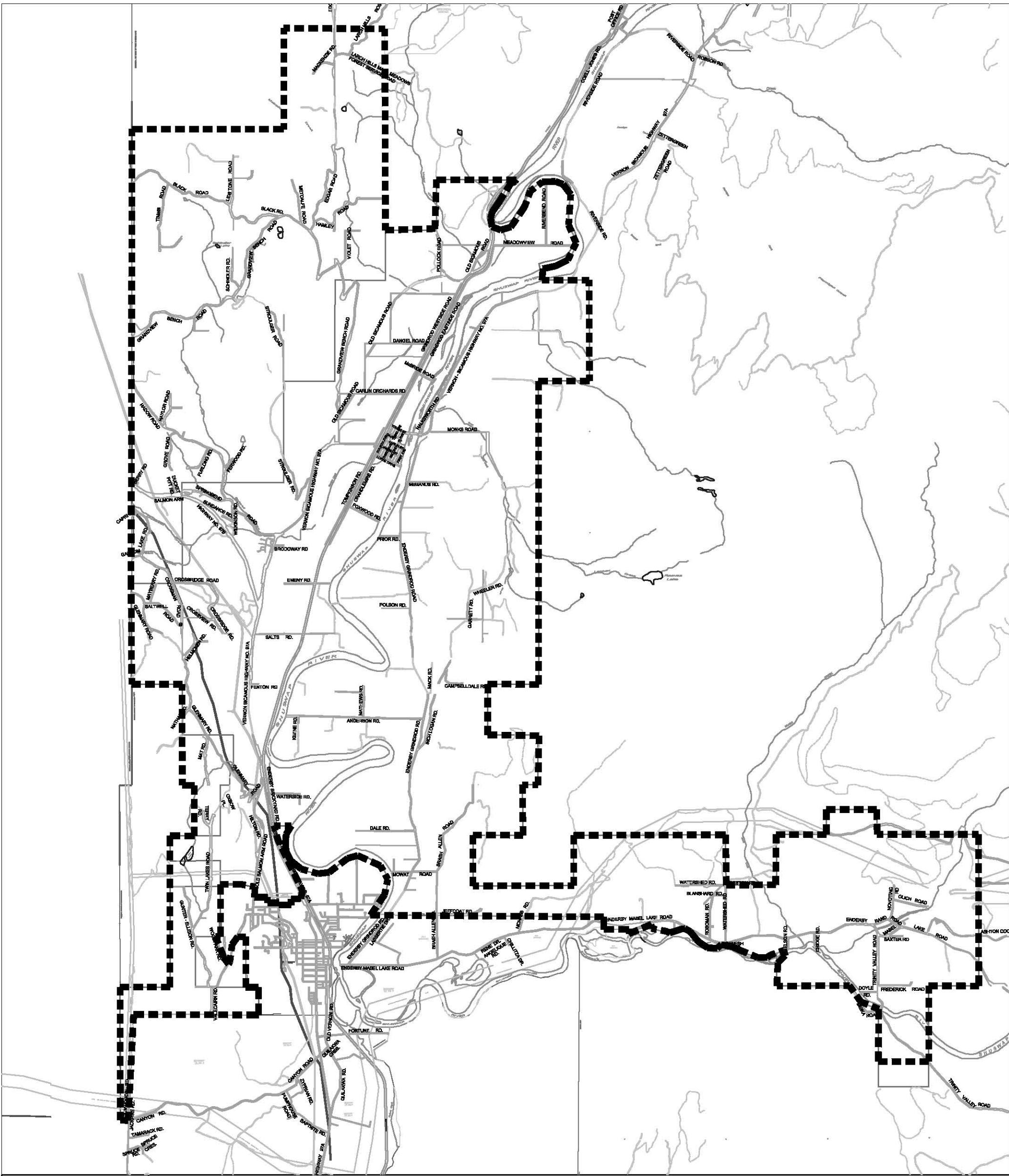
**NOW THEREFORE** the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

1. The Extended Service of Animal Control is hereby established;
2. *The service area and the participating area for the service is the specified part of Electoral Area "F" shown outlined on the map marked Schedule "A" attached to and forming part of this bylaw. The service area established by Section 1 shall encompass and the participating areas for the extended service shall include the Corporation of the City of Enderby and that specified part of Electoral Area "F" shown outlined on the attached map marked Schedule "A" and forming part of this by-law;*
3. *The annual cost of the service shall be recovered by a property value tax under Section 803(1)(a) of the Local Government Act. The property value tax is to be imposed on the basis of net taxable value of land and improvements in the participating areas, consistent with Section 804.3(5)(a) of the Act. The requisition of funds under Section 806 of the Local Government Act will be collected from the participating areas in accordance with Section 806.1 of the Act.*

~~The annual operating costs for this service shall be recovered:~~

- ~~a. by the imposition of licence and impoundment fees;~~
- ~~b. the balance after deducting the revenue obtained from the licence and impoundment fees shall be apportioned between the member municipalities on the basis of 75% in the City of Enderby and 25% in the specified part of Electoral Area "F" and shall be recovered by requisition under Sections 809 and 809.1 of the Municipal Act to be levied and collected under Section 810 and 810.1 of the said Act;~~
- ~~b. the balance after deducting the revenue obtained from the license and impoundment fees shall be apportioned between the member municipalities on the basis of 68.68% in the City of Enderby and 31.32% in the specified part of Electoral Area "F" and shall be recovered by requisition under Sections 805 and 806 of the Local Government Act to be levied and collected under Sections 805.1 and 806.1 of the said Act."~~
4. *In accordance with Section 13(1)(b) of the Community Charter, the Board of Directors of the Regional District has given consent to the City of Enderby to provide the service, subject to the terms and conditions as set out in "The Corporation of the City of Enderby Service Extension and Commission Delegation Bylaw, No. 1446, 2009".*
