BY-LAW NO. 1082

(Consolidated for Convenience Only – Refer to Original Bylaw)

A bylaw of the Regional District of North Okanagan to convert and establish a local service area for the supply, treatment, conveyance, storage and distribution of water for Silver Star Village

WHEREAS the Regional Board by By-law No. 826, 1989 established the "Silver Star Village Water Specified area" to provide a community water system to the community now known as Silver Star Village;

AND WHEREAS pursuant to the provision of Section 767(4) of the Municipal Act, the Regional Board has determined to convert, establish and amend the aforesaid specified area;

AND WHEREAS the Regional Board has obtained the consents required under the provisions of Section 802 of the Municipal Act;

NOW THEREFORE the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

- 1. The "Silver Star Village Water Specified Area" as established by "Silver Star Village Water specified Area Establishment By-law No. 826, 1989" is hereby converted and established as a Local Service Area for the supply, treatment, conveyance, storage and distribution of water for Silver Star Village.
- 2. The service area now converted and established by Section 1 shall be known as the Silver Star Village Water Local Service Area and such area shall be comprised of that tract of land located within District Lot 1355, O.D.Y.D.

The service area now converted and established by Section 1 shall be known as the Silver Star Village Water Local Service Area and such area shall be as outlined on Schedule "A" attached hereto and forming part of this bylaw. $(B/L 2126/06)^{A}$

- 3. The Regional District is authorized to carry out or cause to be carried out and provide the local service of supply, treatment, conveyance, storage and distribution of water in the said local service area including the purchase of all easements and appurtenances incidental thereto located in and for the service area.
- 4. The annual operating and debt servicing costs shall be recovered from the said service area by;
 - (a) the requisition of money under Section 809.1 of the Municipal Act to be collected by a property value tax to be levied and collected under Section 810.1 of the said Act; on land only; and

- (b) the imposition of fees and charges that may be fixed by separate by-law for the purpose of recovering the costs.
- 5. The maximum amount that may be requisitioned for annual operating and debt charges shall not exceed a levy of Five Dollars (\$5.00) per One Thousand Dollars (\$1000.00) on net taxable value of land included in the service area.
- 6. This by-law may be cited as the "Silver Star Village Local Service Area Conversion and Establishment By-law No. 1082, 1992".


