REGIONAL DISTRICT OF NORTH OKANAGAN

BY-LAW NO. 1056

A By-law of the Regional District of North Okanagan to convert and establish the B.X. - Swan Lake Fire Protection Specified Area as a Local Service Area and to amend the boundaries to include the Forsberg Road Area.

WHEREAS the Regional Board by-law No. 217, 1976 established the "B.X. - Swan Lake Fire Protection Specified Area" which boundaries were amended by-law No. 232, 1977;


AND WHEREAS a valid petition from residents of Forsberg Road requesting fire protection services has been certified by the Secretary of the Regional District of North Okanagan;

AND WHEREAS pursuant to the provisions of Section 767(4) of the Municipal Act, the Regional Board has determined to convert, establish and amend the aforesaid specified area;

NOW THEREFORE the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

- 1. The "B.X. Swan Lake Fire Protection Specified Area is hereby converted and established as a Local Service Area for fire prevention and suppression.
- 2. The service area now converted and established by Section 1 shall be known as the <u>B.X. Swan Lake Fire Protection Local Service Area</u> and shall be enlarged to include the Forsberg Road area and Silver Star Road leading up to and abutting the Silver Star Village Fire Protection and Control Area boundary and shall encompass the area as shown outlined on a map marked Schedule "A" attached to and forming part of this by-law.
- 3. The Regional District is authorized to undertake and carry out or cause to be carried out and provide the local service of fire prevention and suppression within the said service area including construction of a fire hall and acquisition of fire equipment; and to undertake Jaws of Life extrication services within the fire protection area funded through the fire department budget and outside the fire protection area when authorized to do so by Provincial authority, providing a mechanism for cost recovery.
- 4. The annual operating and debt servicing costs shall be recovered from the said service area by the requisition of money under Section 809.1 of the Municipal Act to be collected by a property value tax to be levied and collected under Section 810.1 of the said Act.
- 5. The maximum amount that may be requisitioned for annual operating and debt charges shall not exceed a levy of Five Dollars (\$5.00) per One Thousand Dollars (\$1000.00) on net taxable value of improvements only included in the service area.
- 6. The Regional District may provide fire prevention and suppression services through its own resources or by entering into contractual agreements.
- 7. This by-law may be cited as the B.X. Swan Lake Fire Protection and Control Local Service Conversion and Establishment By-law No. 1056, 1992.
