**REGIONAL DISTRICT OF NORTH OKANAGAN**

**BYLAW No. 1095**

A Bylaw of the Regional District of North Okanagan to establish the local service of Fire Prevention and Suppression to the community known as Silver Star Village.

---

**WHEREAS** the Regional Board of the Regional District of North Okanagan has been requested to establish a service area for the purpose of providing fire prevention and suppression services to the community of Silver Star Village located within Electoral Area "C";

**AND WHEREAS** a valid petition has been certified by the Secretary of the Regional District of North Okanagan;

**AND WHEREAS** Section 788 of the Municipal Act authorizes the Regional District to establish and operate the local service of Fire Prevention and Suppression;

**AND WHEREAS** the required consents have been received by the Secretary of the Regional District of North Okanagan;

**NOW THEREFORE** the Regional Board of the Regional District of North Okanagan in open meeting assembled enacts as follows:

1. The Regional District of North Okanagan hereby establishes in Electoral Area "C", a local service area for fire prevention and suppression ***and the provision of assistance in response to medical emergencies by first responders*** (herein called "fire prevention and suppression").
2. The Service area now established by Section 1 shall be known as the Silver Star Village Fire Protection Local Service Area and shall be comprised of that ~~tract of land located within District Lot 1355 O.D.Y.D.~~ ***those lands within the 'Service Area Boundary' as shown on Schedule 'A' attached hereto and forming part of this Bylaw.***
3. The Regional District is authorized to carry out or cause to be carried out and provide the local service of fire prevention and suppression within the said service area including purchase or lease of land, construction of a fire hall and acquisition of fire equipment.
4. The annual operating and debt servicing costs shall be recovered from the said service area by the requisition of money under Section 809.1 of the Municipal Act to be collected by a property value tax to be levied on land and improvements and collected under Section 810.1 of the said Act.
5. The maximum amount that may be requisitioned for annual operating and debt charges shall not exceed a levy of Five Dollars (\$5.00) per One Thousand Dollars (\$1000.00) on net taxable value of land and improvements included in the service area.
6. The Regional District may provide fire prevention and suppression services through its own resources or by entering into contractual agreements.
7. This bylaw may be cited as the ***"Silver Star Village Fire Protection and Control Local Service Area Establishment By-law No. 1095, 1993"***.

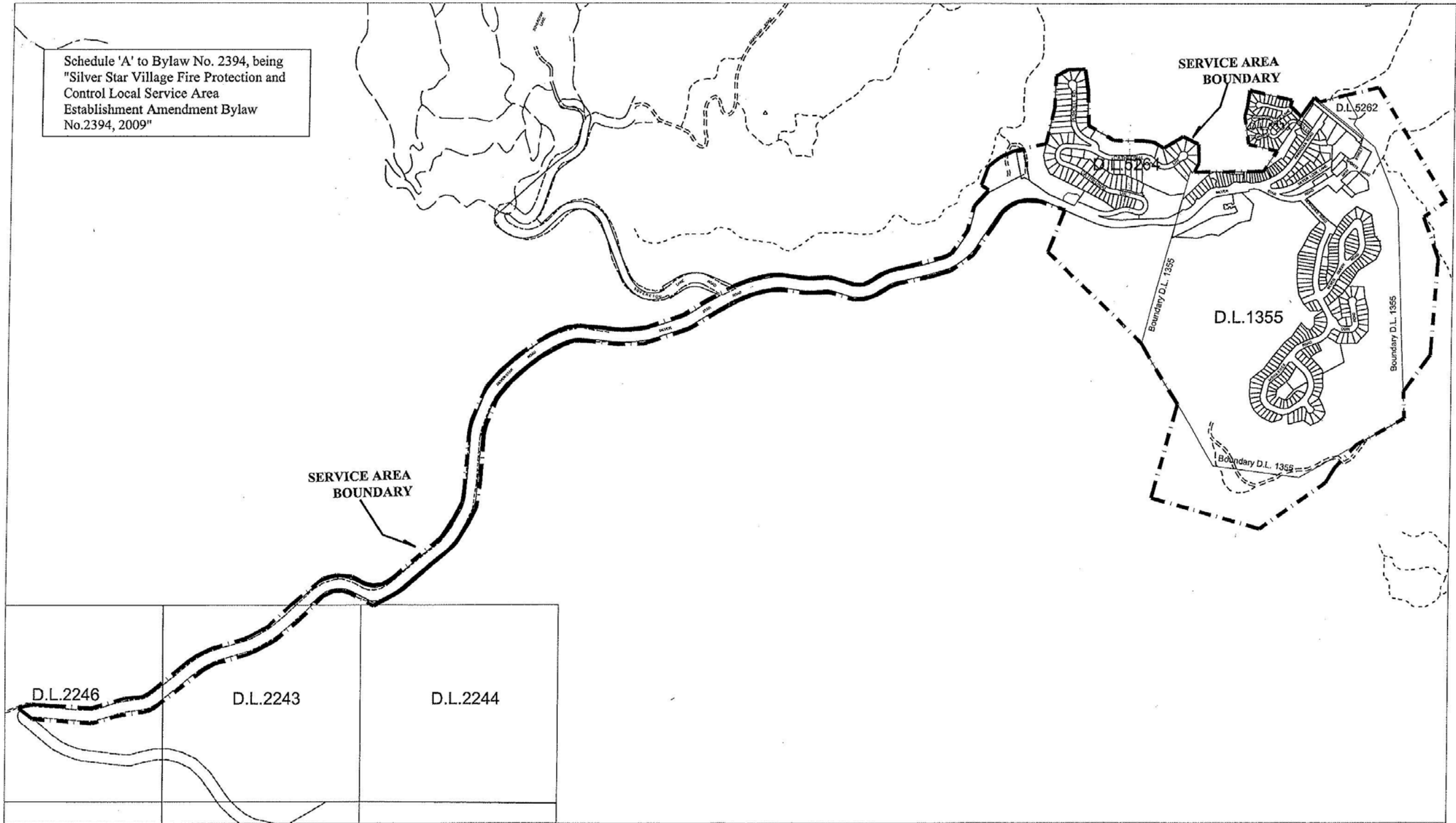
